1. In preparation for the 2026 Eastern Visayas Regional Athletic Association (EVRAA) Meet in Baybay City, this office, through the School Governance and Operations Division, informs the field of the conduct of the **Deliberation on January 12-13, 2026** and **Finalization of Qualified Athletes on January 15-16, 2026 at the SDO Biliran Conference Hall.**
2. These activities aim to choose the best athletes to represent SDO Biliran in the 2026 EVRAA, targeting an improved medal tally.
3. The Deliberation will involve the Division EVRAA 2026 Selection Committee, Tournament Directors or their representatives, and Secretariat.  - b. For measurable events, tournament directors shall present and make comparison in the standard time and measure;
 - c. Finalize medal tally.






