SHIFTING TO ALTERNATIVE DELIVERY MODE (ADM) OF LEARNING FOR ATHLETES UNDERGOING TRAINING AND PARTICIPATING IN THE EVRAA

1. In preparation for the **Eastern Visayas Regional Athletic Association (EVRAA)** and to ensure the holistic development of learner-athletes, this Office hereby informs all concerned that **qualified athletes who will undergo training and officially participate in the EVRAA shall be allowed to shift to Alternative Delivery Mode (ADM)** for the duration of their training and competition.
2. This is issued in consonance with the Department of Education's commitment to balancing **academic excellence and sports development**, and pursuant to **DepEd Order No. 021, s. 2019**, which emphasizes learner-centered and flexible learning approaches to address diverse learner needs and **DepEd Order No. 012, s. 2020**, which provides the policy guidelines on the adoption of **Alternative Delivery Modes (ADM)** to ensure continuity of learning.
3. Under this arrangement, learner-athletes shall be provided with appropriate learning tasks, modules, performance outputs, and assessment tools that may be completed through ADM, after their participation to the concentration and EVRAA without compromising learning standards and academic requirements. Teachers concerned are enjoined to coordinate closely with coaches, school heads, and parents to monitor learners' academic progress during the training and competition period.
4. School Heads shall ensure proper documentation, supervision, and implementation of this policy, while maintaining accurate records of


