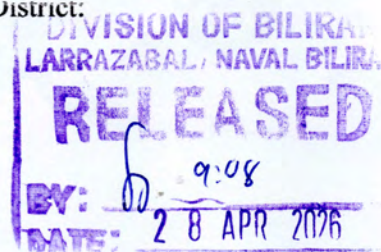

POST IMPLEMENTATION REVIEW FOR SY 2025-2026**



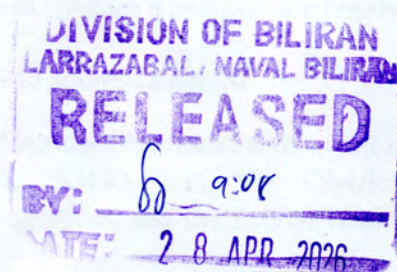
- 1.) The Schools Division Office of Biliran, through School Governance and Operation Division – School Health and Nutrition Section (SGOD – SHNS) shall conduct a one-day **School-Based Feeding Program (SBFP) Post-Program Implementation Review for SY 2025-2026** on **May 14, 2026**, to start at 8:00 o'clock in the morning at **Fragoch Tourist Inn, Naval, Biliran**.
